Topic: "Is Harry Potter a Freemason?"

In the books from "Harry Potter and the Sorcerer's Stone" (British title) to "Deathly Hallows", a careful reader can find multiple Masonic symbols. The first book alone traces Harry's journey as an E.A. How? Come and listen to the talk. By reviewing how Masonic symbolism can be found in the Harry Potter books where you least expect, it may be found elsewhere. After the presentation, you may want to take another look at other pieces of literature, movies, and plays in new light, looking for the hidden and sometimes not so hidden Masonic symbols.

He is President and long-time supporter of the George Washington Masonic Stamp Club. He has published numerous Masonic and other articles and is regularly talks on a large variety of subjects.





Minutes of March 3, 2018

Following the luncheon, a meeting of the Maryland Masonic Research Society was called to order at 1:00 p.m. in the Temple of the Silver Spring Lodge No. 215 by President Anne-Marie Moody.

The attendance totaled 14 with 12 Companions and two (2) guests. Please refer to the Attendance Book for more detail.

The Invocation was given by our Chaplain and P.P., John Maclay. The Minutes of our December 2, 2017, were approved as distributed. The Secretary reported we received notices from the Masonic Service Association of North America and a Trestleboard from a Maryland Lodge and these will be made available in Member Resources. There was one (1) petition to be voted on, Johnny Law, that was recommended and approved. Payment of the bills was recommended, seconded, and approved.

Past President Ed Johnson presented on "Muses Threnodie: Poetic License or Historical Insight?" This was an exploration on what was meant in terms of the relationship of the Rosicrucians and Freemasons given the wording, "For we are the Brethren of the Rosie Cross, we have the Mason's Word..." in this Scottish poem from 1638. The relationships of the author, his family, and other figures were explored as well as the theory of J.G. Buhle and response of A.E. White. There were lively questions and a warm round of appreciation for the presentation. We requested the presentation be sent to the Secretary to add to the Member Section of the MMRS website.

After our Chaplain led us in our devotions, President Anne-Marie Moody adjourned the meeting at 2:30 pm in peace and harmony.
